

**CABELL MIDLAND HIGH SCHOOL**  
**STUDENT DRIVING GUIDELINES WHILE ON SCHOOL PROPERTY**

Students planning to drive cars to school must be prepared to follow these guidelines:

1. Students must have a valid driver's license, valid vehicle registration for primary vehicle, valid proof of insurance and be a registered participant in the Cabell County School Board drug testing program. This proof must be on file in the 12<sup>th</sup> grade office prior to the student being permitted to drive on campus.
2. Students must have a current CMHS parking permit for the 2015-2016 school year issued by the administration.
3. Cars must be parked in the student parking lot. You must exit your vehicle immediately after parking.
4. You may not return to your vehicle during school hours.
5. **Failure to display parking permit or properly register vehicle and/or the neglect to follow any of the driving on property rules will result in loss of parking privilege and/or school discipline.**
6. Use of your vehicle without written permission from an administrator will result in the loss of parking privileges and/or suspension as per Cabell County Code.
7. You must follow all traffic laws such as speed limits, stop and yield signs, etc... Failure to do so will result in loss of parking lot privileges and/or school discipline.
8. Students **not** able to secure a parking permit, **may not** park on school property.
9. Students who use excessive speed, drive recklessly, or otherwise display a disrespect for proper traffic/parking operations and regulations will be subject to one or more of the following disciplinary actions: suspension or revocation of parking permit; vehicle removed from parking lot; suspension from school; detention or other penalties as assessed by the assistant principal.
10. Parking Permit Cost: \$40.00; Reinstatement Fee: \$5.00. No refunds will be issued.
11. The security guard will collect parking tags the entire day for all tardy students.
12. Students who are tardy to school for the 3<sup>rd</sup> time will lose parking privileges for **10 school days**. Every additional 3<sup>rd</sup> tardy to school will result in losing the student's parking pass for additional **10 school days**.
13. Ten consecutive or fifteen total unexcused absences will constitute the school requesting for the student's drivers license to be revoked, as required by State Law.
14. Students are only allowed to drive and park on the main student lot. All other lots are for adult use only. This includes practices, games, & instructional times.
15. Student vehicles will be subject to random searches and/or searches for infraction of student code of conduct.

**\*\*\*Cabell County School and Cabell Midland High School will assume no responsibility of damages/theft to your vehicle while parked on school property.**

**\*\*If you change vehicles during the year, you must report this to the office.**
